

I am to communicate observations/recommendations of the Inspection Committee that had visited your institution on 05.03.2019 in connection with your request for the continuation of provisional affiliation for the B.Tech Courses in RAAK College of Engineering & Technology, Puducherry for the academic year 2019-20.

The Inspection committee has recommended continuation of provisional affiliation for the following courses as indicated against each for the academic year 2019-20, subject to fulfillment of the following conditions:

Observations/recommendations of the Inspection Committee:

1. A.I.C.T.E. approval for existing UG courses for the academic year 2019-20 should be furnished.

2. The shortcomings noted by the last Inspection Committee should be rectified fully.

4. Suitable legal/open source software should be procured.

5. Student - faculty ratio and cadre ratio should be fulfilled as per AICTE norms.

6. Senior faculty should be recruited immediately.

7. Adequate technical staff should be appointed

8 Non-teaching staff are inadequate

9. Payment of salary as per UGC/AICTE norms should be implemented to Faculty and staff immediately.

10. Books and journals should be added to the Library.

11. Computing facilities particularly Peripherals should be added

You are required to rectify/comply with the above deficiencies and submit the compliance report with supporting documents/proof within 10 days from the date of receipt of this letter.

You are also required to submit:

- An undertaking on a non judicial Stamp paper, duly attested by a Notary Public for fulfilling the affiliation conditions prescribed by the University in the Annexure to this letter.
- A sum of Rs.2,00,000/- should be remitted towards affiliation fund for UG Courses and Rs.53,000/- towards Inspection fund in the form of Demand Draft drawn in favour of the Finance Officer, Pondicherry University, Puducherry.

Failure to pay the required fund within 10 days from the date of receipt of this letter would attract penalty as follow

Late Fund:

Upto 15 days : Rs.50,000/-

Upto 30 days

:Rs1,000,000/-

Beyond 30 days Rs.1,00,000/- + Rs.4,000/- per day for a period of one month..

You may please note that extension of provisional affiliation for the academic year 2019-20 would be considered only on rectification of the above shortcomings and submission of compliance report with supporting documents immediately.

Admission to these courses for the Academic year 2019-20 should not be made without the approval of the University, failing which strict action would be taken against the College and the College alone would be responsible for the same.
