



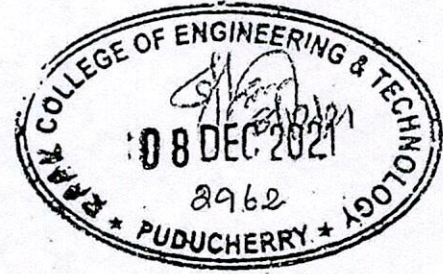

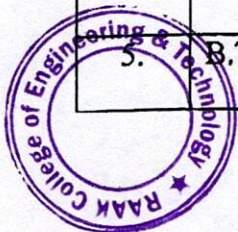

**Observations of the Inspection Committee:**

1. Qualified faculty should be recruited for all departments using duly constituted Selection Committee with University Nominee. (Existing faculty recruitment is carried out without University representation).
2. Text Books & Reference Books need to be purchased for all Courses. At present Reference Books are not relevant and adequate.
3. IEEE, ACME, ASCE Journal subscriptions should be made available.
4. No AICTE prescribed Journals available.
5. Only DEL NET subscription is available. Subscription to all E-Journals mentioned above as per the AICTE norms should be facilitated.
6. Adequate Computing facilities should be made available. Many computers are dysfunctional.
7. Licensed Softwares as per Curriculum & Syllabus should be made available.
8. Separate Computing laboratory facilities for every course should be made available with adequate number of Computers.
9. Laboratories of all courses should be equipped with adequate laboratory equipments.
10. EOA from AICTE to be obtained for every year.

You are requested to rectify the above deficiencies and submit a compliance report along with supporting documents / proof. You are also required to submit an Undertaking on a non judicial Stamp paper, duly attested by a Notary Public for fulfilling the affiliation conditions prescribed by the University in the Annexure of this letter.



Beyond 30 days	- Rs.1,00,000/- + Rs.4,000/- per day for a period of one month.



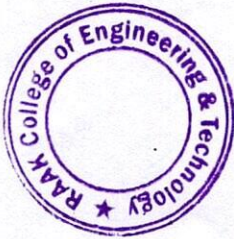
The College should not admit students to the above courses for the academic year 2021-22 without the approval of the University.
